Respiratory protection:



In case of brief exposure or low pollution use respiratory filter device. In case of intensive or longer exposure use self-contained respiratory protective device.

Air-fed respiratory protective equipment must be work when this product is sprayed. In case of low exposure, eg brush painting, use a respiratory filtering device.

Under dry, cool conditions it is possible for the isocyanate to remain unreacted in the paint film for up to 30 hours after application. If dry flatting is unavoidable, use air-fed respiratory protective equipment.

Protection of hands:

Due to missing tests no recommendation to the glove material can be given for the product/ the preparation/ the chemical mixture.

Selection of the glove material on consideration of the penetration times, rates of diffusion and the degradation

The glove material has to be impermeable and resistant to the product/ the substance/ the preparation.

Material of gloves

The selection of the suitable gloves does not only depend on the material, but also on further marks of quality and varies from manufacturer to manufacturer.
